### 3. Matters Arising

**The Slate:** SB confirmed that the Slate is now 'gifted' to the Town Council and will therefore be included on their insurance.

**Locally listed buildings:** WR to follow up with NNDC the possibility of obtaining national listing for the Post Office. Would NNDC be able to lead this process?

Agreed to visit the town centre as a group at a later date with a view to identifying other buildings that the Society feel should be included on the list.

WR to find out the date of the current list.

**Concern re. Cottage Collectables on Star Plain (nationally listed) and Praze Cottage** in Bull Street: SB to write to the conservation officer ( Paul Rhymes ) at NNDC to remind them of their duty of care to nationally listed buildings and see if they can pressure the landlord to make remedial improvements.

**Payment for 'Strolls':** NC reported that he had been unsuccessful in chasing NNDC for the £60 they owe the Society. GD will investigate and report.

**Reprint of 'Strolls' and John Roebuck's book:** TL reported that updating Strolls is best kept until the Town Trail is up and running and that he is awaiting an estimate for the reprint of JR's book. There are 20 copies left.

**Committee Vacancy:** No decisions were made.
